What makes a law firm eligible to receive a *U.S. News – Best Lawyers*® "Best Law Firms" ranking? To be eligible to participate in the "Best Law Firms" submission process, a firm must have at least one attorney who has received high enough peer-review to be listed in the current edition of *Best Lawyers*.

Do the "Best Law Firms" rankings affect Best Lawyers traditional listings?

Best Lawyers listings will continue to be compiled according to an annual peer-review survey.

What are the "Best Law Firms" rankings based on?

The "Best Law Firms" rankings are based on a combination of client feedback, information provided on the Law Firm Survey, and *Best Lawyers*.

What additional information, if any is reviewed, beyond the peer review and information provided by the firm?

For *Best Lawyers*, we use only the votes received from the attorneys. "Best Law Firms" uses some additional surveying material (see below).

How are we evaluated if we are unable to submit clients because of the nature of our practice? Practice areas that tend to prohibit release of client information or those that tend to be more sensitive in nature, like Medical Malpractice Law – Plaintiffs, will be evaluated with more reliance on *Best Lawyers* peer-review and the Law Firm Survey.

Who ultimately reviews the information that is collected to determine which/who will be named to the "Best Law Firms" or "Lawyer of the Year" list?

We have a small team on our end as well as a computer system which are used to tally information. We look at each attorney mainly to verify that the votes received are accurate to their listing, and also to review comments.

Are there ever any fees associated with participation in the submission process or receiving a ranking in "Best Law Firms?"

No. There are no fees associated with submitting information or receiving a ranking.
