- Evidence indicates that millions of children under 13 on Facebook and parents are helping them sign up
- Current system is not designed to help parents protect those children.
- Pressure from some regulators to offer “training wheels”

- + Welcome email for parent linking to dashboard and providing additional information
- + Welcome email for children highlighting safety tips and resources (abuse reporting, social reporting)
- + PSAs and other information for parents and children

parents are joint administrators

- + Parents can log into their child's account
- + Parents can see actions / connections child makes through the child's Activity Log -- e.g.,
 - Posts on others timeline
 - When child tagged or tags another
 - Likes, comments, status updates
 - Groups/events joined
- + Parents can take actions within account

proposals for under 13s

- + Timeline/profile fields: Friends
- + Posts: Friends
- + Who can post on timeline/profile: Friends
- + Who can tag: Friends
- + Who can message: Friends
- + Who can send friend request: < 13 and FOF
- + Who can search by name/contact: < 13 and FOF
- + Can send friend requests to: Everyone

notification options

+ Proposed notification options for parents

- receives or sends friend request
- Joins a group (even secret groups)
- RSVPs to an event (even invite only events)
- Subscribes to a user or interest list
- Starts a new chat / message thread with non-friend
- Is tagged in a post/photo

Adds or removes a parent

other possible notifications

+ Other potential notices

- Adds a Friend
- Likes a Page
- Comments on a Page (any public space?)
- Updates profile information, profile picture, life events
- Posted on another user's timeline
- Someone posted on their timeline

age gating

- + Normal age gating will continue, plus enhancements
- + Apps will have to opt in to being available to under 13s
- + Page Admins will have to opt out of being visible to under 13s
- + UO will be able to lock an object or piece of content into a specific age-gating setting as they review/report suspicious content

advertising

- + Kids see ads from a limited group of carefully selected partners at launch
- + No ads with social context at launch
- + Only available for select verticals
- + Review process is 100% manual
- + We will devote inventory to PSAs that help to educate kids on how to use the site safely
- + Kids not in Ads and Featured Stories
